The 3Monkeez in-floor industrial waste arrestors are intended to be fitted to commercial or industrial drains to capture and retain solid waste that would normally finish in the sewerage system.

Solid waste is captured in a perforated basket contained within the main body of the arrestor device. Retained solids are then removed to waste. A fixed perforated screen to the bottom of the main body prevents any solid waste entering the sewer if the basket is accidently or deliberately left out of the arrestor device.

All of the products carry the WaterMark accreditation as authorised by SAI Global.
